- 3) Proof of detail of work executed / being executed since last three years including name of the owners. Project cost, scope of work, date of commencement / completion and detail payments received with amount and date.
- 4) The firm must be sole distributor for the items / equipments they are bidding.
- 5) The firm must ensure after sale services / maintenance supply of parts and hand on training for the equipments, Where applicable
- 6) Proof of staff and machinery owned by the firms.
- 7) Financial statement of the schedule banks in the name of firms for the last three years also provide proof of bank balance on **31.12.2021**.
- 8) Proof of present assets owned and held by the firms as stood on **31.12.2021**.
- 9) Detail of any arbitration / litigation processing against any govt. / Semi Govt. Department showing extent and results.
- 10) Undertaking on judicial paper that the firms was never black listed by any of the Govt. / Semi Govt. organization in the past.
