The terms and conditions / procedure of tenders are given below:

- The intending Contractors/Firms who have been registered with Pakistan Engineering Council in the relevant category / codes active with FBR for current year and experience in the relevant field may participate.
- The Contractors / Firms have to be registered on Punjab PPRA website (www.punjab.eprocure.gov.pk). Any information / procedure regarding registration can be seen / obtained from website ppra.punjab.gov.pk/e-procurement.
- The bidder shall submit hardcopy of the financial instrument in addition to the scan copy uploaded at e-PADS as bid security, 2% of Estimated Amount in the form of CDR in favor of Treasurer, University of Sargodha, well before the closing date and time in the office of Project Director (Works) / University Engineer as the case may be, otherwise bid shall not be entertained.
- Bids should be submitted through e-PADS (Electronic-Pak Acquisition and Disposal System) and the same should be opened online as per above mentioned schedule. Only e-bids submitted through e-PADS shall only be entertained / accepted.
- After filling the bids on website, contractors may attend the office of Project Director (Works) on September 23, 2025 (Tuesday) at 11:30 AM, where
 all bids will be retrieved and quoted rates / successful bidder will be announced in the presence of Tender Opening Committee.
- In case of submission of any fake information / document such as CDR / receipt, the Contractor/Firm will be disqualified from the current tendering procedure and will be black listed to participate in any tendering process of Building & Works Department. Further recommendation to PPRA and PEC will also be made against such firm/contractor for appropriate action/ black listing.
- The procuring agency may reject all bids or proposal at any time prior to acceptance of a Bid or proposals under PPRA Rule-35 (Rejection of Bids).
- Recovery against credit of old material will be adjusted manually and accordingly bids will be evaluated.
- No price variation shall be admissible for the Repair Schemes.
- No mobilization advance / secure advance of any kind will be given.
- All the bidders shall be required to quote item rates against each item of work mentioned in every page of approved DNIT / BOQs. The rates quoted in percentage above or below than approved cost will not be considered / accepted.
- All taxes / deductions will be made as per Govt. Rules amended / revised time to time.
