The Vice-Chancellor is pleased to approve the following Admission Schedule and Schedule for submission of Registration Return / University Dues etc. for Undergraduate / Graduate Programs (Term system) for the session 2017-18 in the Affiliated Colleges of this University: -

Note: No late admission is allowed under Term System. Moreover, no supplementary case shall be accepted under Term System, Registration Return must be submitted by due date otherwise it shall not be entertained.

UNIVERSITY DUES

- Registration Dues/ University share shall be deposited for each discipline as per enclosed detail. (Annexure-A)
- The University dues must be deposited in HBL University of Sargodha Account No.04237900379501 on or before the due date, failing which an additional amount of Rs.2000 per student shall be charged for delay in deposit of dues provided that Registration Return has been submitted within given time limit.
- University dues for each discipline should be deposited through Bank Draft or New Bank Challan specified for Registration Branch. (Annexure-B). The same is available on University website. **The challan form must bear the detail of discipline and break up of fee. Banker Cheque or deposit in other account shall not be accepted at all.**
- Excess dues deposited by Affiliated Colleges shall not be adjusted in any discipline other than for which they have been deposited. Moreover excess amount of one academic session shall not be carried forward to next session. However, it may be claimed as refund case through Treasurer, University of Sargodha.

- v. In case of struck off / left out students from Affiliated Colleges, the college management is bound to submit a list of such students within 15 days from date of admission and University share of such students will be waived off. However this relaxation will not be applicable for students struck off in the one year programs.
- vi. **20 % surcharge per month** will be received on arrears of the Registration/Enrollment / Sports Fee and University Share if any.

6. **ELIGIBILITY**

- i. The eligibility of students shall be determined for each discipline as per enclosed criteria. **(Annexure C)**. If any confusion related to the eligibility criteria arises, please contact Registration Branch for clarification before admission.
- ii. **Admission of candidates with compartments and supplementary exam in the same academic year is not allowed.**
- iii. In case of students from **AIOU**, only those students will be eligible to get admission for session 2017-18 who have completed their previous degree by Fall 2016 or earlier.
- iv. **Upper age limit** for admissions at Undergraduate level has been fixed at **30 years** and for Master Level has been fixed at **40 years** for Affiliated Govt. / Private Colleges. Admission of overage students shall not be accepted at all.
- v. All documents (CNIC, Transcripts, N.O.C, Registration Form) must be submitted along with Registration Return within due date. No student shall be issued Registration Number provisionally or otherwise in absence of NOC.
- vi. Due care should be taken while making admissions and reporting them in Registration Return from Eligibility point of view. For every ineligible student included in Registration Return, a fine of **Rs.2000/-** per student shall be levied **upon College Management and responsibility of the admission of such students will rest on the Management of College concerned.**

7. **REGISTRATION RETURN SCHEDULE**

- i. The Registration Return should be submitted in accordance with the instructions enclosed. **(Annexure-D)**
- ii. The discrepancies, if any, will be communicated to the colleges and Affiliated Colleges must remove those discrepancies **within 15 days** of receipt of letter. **Beyond 15 days**, Registration Return shall be treated as new and calculation of dues and fine shall be made accordingly.
- iii. No admission can be withdrawn or transfer to another discipline once the Registration Return has been submitted to the University.

5. The Principals of Affiliated Colleges are requested to follow the above mentioned schedule in letter and spirit.

- Age limit for Masters Level has been fixed at **40 years** for Affiliated Govt/ Private Colleges.
- Age limit for Undergraduate level has been fixed at **30 years** for Affiliated Govt/ Private Colleges
- No age limit for M.Ed and ADCP
- Admission of overage students shall not be accepted at all.

The eligibility of students shall be determined for each discipline as per given criteria. If any confusion related to the eligibility criteria arises, please contact Registration Branch for clarification before admission.

▪ ***Foreign Degree Holders:**

The merit of candidates holding 'O' Level 'A' Level and other foreign certificates will be determined on the basis of equivalence certificates issued by the Inter Board Committee of Chairmen (IBCC), Ministry of Education, Government of Pakistan, Islamabad.

▪ **Wafaq ul Madaris Al-Arabia Degree Holders:**

The Final Sanad "Shahabatul Almiya Fil Uloomal Arabia wal Islamia" awarded by Wafaq ul Madaris Al-Arabia as equivalent to M.A Arabic / Islamic Studies as per decision of Equivalence Committee of erstwhile UGC only for the purpose of teaching Arabic and Islamic Studies in Colleges and Universities and for pursuing higher studies. Vide HEC Letter No: 8-16/HEC/A&A/2005/207 dated: 10-02-2005.

▪ **AIOU Students:**

In case of students from AIOU only those students will be eligible to get admission for session 2017-18 who have completed their previous degree by Fall 2016 or earlier.

Guidelines to Prepare Registration Return

1. The Return should be submitted on new proforma provided by the Registration Branch, University of Sargodha (Enclosed.) The same is available on University website also.
2. The return should be typed. Hand written return shall not be accepted.
3. Registration Return must be accompanied with the covering letter and academic documents of students. Soft copy with scanned photographs shall also be required on CD or through e-mail registration@uos.edu.pk
4. Exact date of admission supplemented with proof should be mentioned on the Registration Return.
5. The NOC column on Registration Return Proforma (new) should be properly checked to indicate whether NOC of the relevant student has been enclosed or not.
6. All the columns of the Return should be carefully filled in. The incomplete Registration return shall not be accepted.
7. The return of already registered students of the UOS may be submitted separately as last page of the Registration Return proforma.
8. For admission under category late admission with the permission of Vice-Chancellor, **late admission forms** shall be provided by the Registration Branch **@ Rs.25 per form**, which shall be collected by the Institutions concerned after deposit of prescribed fee.
9. In case of submission of Registration Return after expiry of admission schedule affiliated colleges shall submit **attendance record** of the student.
10. No Registration Return will be entertained without documents (i.e. Last Result Card, ID Card, NOC, Notification from Affiliation Branch etc)
